**Subject: Release of Balance Funds of Grants-in-aid to Union Territory of Puducherry for Flexible Pool for Communicable Disease- SCSP (Scheduled Castes Sub Plan) for the year 2017-18.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of to the payment of **Rs.4,00,000/- (Rupees Four Lakh Only)** to the Union Territory of Puducherry towards balance funds of Grants-in-Aid for **Flexible Pool for Communicable Disease** during 2017-18.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-1/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
3. The Territory shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The Territory shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
5. The Budget of UTs will be funded 100% by the Central Government vide O.M. of Ministry of Finance, Department of Expenditure, Finance-II Division dated 05.02.2016.
6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
8. The expenditure covered by this sanction will be met from the funds provided under Major Head – 3602- Grants-in-aid to Union Territory with Legislature (Major Head); 06 - Centrally Sponsored Schemes (Sub-Major Head); 789 – Special Component Plan for Scheduled Castes (Minor Head); 01- National Rural Health Mission; 01.03- Flexible Pool for Communicable Diseases; .01.03.31- Grants-in-aid - General in Demand No.42 – Health & Family Welfare during 2017-18 (Plan).
9. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
