- FA/CCA or the CA of the functional service Ministry/Department is required to issue annual budget allocation letter.

- c. The amount so allocated/earmarked will not be available for re-appropriation by the functional Ministry/Department except with the concurrence of the Agent Ministry/Department
- d. The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department
- e. The expenditure is to be incurred by UT of Andaman & Nicobar Island as per approved action plan 2017-18 and entrusted by the Directorate General of Health Services, Ministry of Health and Family Welfare.
- f. Expenditure other than the item No. (e) Can be incurred out of the above allocation only after the approval of Ministry of Health and Family Welfare.
- g. Condition that final accounts have to be settled based on the actual expenditure incurred by UT Andaman & Nicobar Island.

You are kindly requested to issue the funds allocation letter urgently. These issues with the concurrence of Integrated Finance Division vide Diary No.C-1158 dated 25.07.2017.
