Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.79,00,000/-** (Rupees Seventy Nine Lakh Only) **to the UT of Delhi towards** balance of Second Installment of Grants-in-Aid for Flexible Pool for Communicable Diseases for the year 2017-18.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid through a Cheque in the name of **Finance Secretary, NCT of Delhi.**
3. The State/UT shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The State/UT shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summery on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
5. Grant in-aid shall be used for the purpose for which sanction is given. A annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
6. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
7. The Expenditure covered by this sanction will be met from the funds provided under Demand No.42 - 3602-Grants in Aid to Union Territory Governments with Legislature-(Major Head), 06789-Scheduled Caste Sub Plan (Minor Head), 01-National Rural Health Mission, 0103-Flexible Pool for Communicable Diseases, 010331-Grants in Aid General for the year 2017-18.
8. The Grants-in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 09.10.1966.
