I am directed to convey the sanction of the President to the payment of Grants-in-aid of **Rs.50,76,000/-** (Rs. Fifty lakh and seventy six thousand only) to the **UT of Delhi** towards the first, second and third instalment of grants-in-aid for implementation of Infrastructure Maintenance (Urban Family Welfare Centres), a Centrally Sponsored Plan Scheme during 2017-18.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977. The payment to the National Capital Territory of Delhi is to be made through a cheque in the name of Finance Secretary, NCT of Delhi.

The expenditure covered by this sanction will be met from the funds provided under Major Head—3602-Grants-in-aid to Union Territory with Legislature (Major Head); 06789- Special Component Plan for Scheduled Castes (Minor Head); 02 – FW-Infrastructure Maintenance; 0203- Urban Family Welfare Centres (UFWCs); 02.03.31- Grants-in-aid – General in Demand No.42– Health & Family Welfare during 2017-18. This amount is for salary of regular staff of State Government, as per Ministry of Health and Family Welfare Office Order No.P.121919/59/2012-NRHM-IV dated 25th May, 2012.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
