FW Bureaux; 14.01.31- Grants-in-aid – General in Demand No.42-Health & Family Welfare during 2017-18. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-2517 dated 29.12.2017.
