I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.7,00,00,000/-** (Rupees Seven crore only) to the State of **Himachal Pradesh** towards the liquidation of Arrears of 2014-15 for implementation of Infrastructure Maintenance (Training of ANM/LHVs – General), a Centrally Sponsored Plan Scheme during 2017-18. With this release, the arrears will be settled up to 2014-15.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Government (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.04-Auxiliary Nurse Midwife(ANM)/Lady Health Visitors(LHVs); 14.04.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2017-18. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.

5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-2517 dated 29.12.2017.
