I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.16,22,00,000/-** (Rupees Sixteen crore and twenty two lakh only) to the State of **Odisha** towards liquidation of Arrears of 2014-15 for implementation of Infrastructure Maintenance (Direction & Administration), a Centrally Sponsored Plan Scheme during 2017-18. The expenditure covered by this sanction will be met from the funds provided under Major Head-3601-Grants-in-aid to State Government (Major Head); 06-Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.01 Maintenance of State/Distt. FW Bureaux; 14.01.31- Grants-in-aid – General in Demand No.42-Health & Family Welfare during 2017-18. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-2516 dated 29.12.2017.
