I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.28,60,000/-** (Rupees Twenty eight lakh and sixty thousand only) to the State of **Sikkim** towards the third instalment of grants-in-aid for implementation of Infrastructure Maintenance (Direction & Administration), a Centrally Sponsored Plan Scheme during 2017-18.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977. The payment to the Government of Sikkim is to be made through a cheque in the name of Finance Secretary, Government of Sikkim.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601-Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 796 – Tribal Area Sub Plan (Minor Head); 05 - FW-Infrastructure Maintenance; 05.01-Maintenance of State/District FW Bureaux; 05.01.31- Grants-in-aid-General in Demand No.42– Health & Family Welfare during 2017-18.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-1749 dated 29.09.2017.
