The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.04-Auxiliary Nurse Midwife(ANM)/Lady Health Visitors(LHVs); 14.04.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2017-18. This amount is for salary of regular staff of State Governments as per Ministry of Health and Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.

5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-175 dated 21.04.2017.
