I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.1,12,23,000/-** (Rupees One crore twelve lakh and twenty three thousand only) to the State of **Uttar Pradesh** towards the liquidation of arrears of 2015-16 for implementation of Infrastructure Maintenance, Urban FW Centres (UFWCs), a Centrally Sponsored Plan Scheme during 2017-18.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06789 – Special Component Plan for Scheduled Castes (Minor Head); 05 - FW-Infrastructure Maintenance; 05.03-Urban Family Welfare Centres(UFWCs); 05.03.31- Grants-in-aid – General in Demand No.42– Health & Family Welfare during 2017-18. This amount is for salary of regular staff of State Governments as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-175 dated 21.04.2017.
