
Subject: Release of Grants-in-aid for RCH Flexible Pool other Programmes -- STSP (Scheduled Tribes Sub Plan).

I am directed to convey the sanction of the President of India to the payment of Rs. **43,10,00,000/- (Rupees Fourty Three crore and Ten lakh Only)** to the following States towards the grants-in-aid for RCH Flexible Pool including other Programmes during **2017-18:-**


- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
- The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- The States shall ensure that 40%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
- The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
- The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 796– Tribal Area Sub Plan (Minor Head); 04- National Rural Health Mission 04.01- RCH Flexible Pool including RI, PPI, NIDDCP; 04.01.31- Grants-in-aid – General (New) in Demand No.42 – Health & Family Welfare during 2017-18.



9. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.


