2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in cash.

3. The UT shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. The UT shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and UTment of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

5. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate in Form **GFR 12 C** as per GFRs, 2017 shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.

6. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.

7. The expenditure covered by this sanction will be met from the funds provided under Demand No. 42, Major Head – 3602- Grants-in-aid to UT Governments, Minor Head-06102- Externally Aided Projects-Grants for Centrally Sponsored Schemes, Sub Head-01- National Rural Health Mission, 0102-National Urban Health Mission-Flexible Pool, 010235-Grants for creation of capital assets (New) during 2017-18.
