5. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

The expenditure involved is debitable to Major Head 3601-Grants-in-aid to State Government, Minor Head-02263-Public Health-Prevention and Control of Diseases, Sub Head 08 -Flexible pool for Communicable disease, 080031-Grant-in-aid under Demand No. 42 of Department of Health for the year 2016-17.
