5. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

6.The expenditure involved is debit to Major Head 3601-Grants-in-aid to State Government, Minor Head-02796-Scheduled Tribe Sub Plan, Sub-Head 3523-Flexible Pool for Communicable Diseases, 352331-Grant-in-aid under Demand No. 42 of Department of Health for the year 2016-17.
