**Sub.: Release of first Installment of Grants in Aid for Flexible Pool for communicable Diseases to Jharkhand State under Revised National TB Control Programme during the year 2016-17.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of Rs.3,69,50,000/- (Rupees three crore sixty nine lakh fifty thousand only) to the State of Jharkhand out of total approval of Rs.1087.07 lakhs (75% of total allocated budget (Cash) of Rs.1449.43 lakhs for the State for the year 2016-17) as first Installment of Grants-in-Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme during the year 2016-17 as lump sum for undertaking various activities for implementation of RNTCP in the State. The release of this funds is subject to the condition that the State Government of Jharkhand would keep up to its commitments & will be strictly utilized as per the guidelines issued by the MoHFW, GoI and report within a month on compliance of transfer of funds to State Health Society Account. Audited Report and Utilization Certificate till the year 2014-15 have been received from the State Health Society, Jharkhand and hence no UC is pending.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.\
3. The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The State shall ensure that 40% of its share based on release of funds by GoI is credited to appropriate accounts.
5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summery on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
6. The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
7. The Expenditure covered by this sanction are non-recurring and will be met out from the funds provided under Demand No.42 - 3601-Grants in Aid to State Government (Major Head), 02-Grants for State Plan Scheme (Sub-Major Head), 02789-Schedule Caste Sub Plan (Minor Head), 35-Public Health-Prevention & Control of Diseases, 3524-Flexible Pool for Communicable Disease-EAC, 352431-Grants in Aid General for the year 2016-17.



8. The Grants-in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 09.10.1966.
