Sir,

I am directed to convey the sanction of the President of India to the payment of Rs. 1,33,000/- (Rupees one lakh thirty three thousand only) to the State of Sikkim as grants-in-aid under National Leprosy Eradication Programme for the year 2016-17.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid through a cheque in the name of Finance Secretary, Government of Sikkim.

3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. The State shall ensure that 25%/10% of its share based on release of funds by GOI is credited to appropriate accounts.

5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

7. The expenditure covered by this sanction will be met from the funds provided under Major Head 3601-Grants-in-aid to State Government, Minor Head-02789 Scheduled Caste Sub Plan, Sub Head 3523-Flexible pool for Communicable disease, 352331-Grant-in-aid under Demand No. 42 of Department of Health for the year 2016-17.


