The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMIRs/SOEs and Statement of funds Positon, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
5. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
6. The expenditure involved is debitable to Major Head 3601-Grants-in-aid to State Government, Minor Head-02263-Public Health-Prevention and Control of Diseases, Sub Head 08 -Flexible pool for Communicable disease, 080031-Grant-in-aid under Demand No. 42 of Department of Health for the year 2016-17.
