

The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

5. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

The expenditure covered by this sanction will be met from the funds provided under Demand No. 42, Major Head – 3602- Grants-in-aid to UT Governments, Minor Head-02789- Special Component Plan for Schedule Caste, 34-Family Welfare-Reproductive & Child Health Programme, Sub Head-3406-National Urban Health Mission Flexible Pool- National Urban Health Mission, 340635-Grant for Creation of Capital Assets during 2016-17(Plan)
