Subject: Release of Grants-in-aid for RCH Flexible Pool up to 75% including Routine Immunization , Pulse Polio and National Iodine Deficiency Disorders Control Programme –**NCT of Delhi.**

Sir,

I am directed to convey the sanction of the President of India to the payment of **Rs. 30,44,00,000/- (Rupees Thirty crores and Forty Four lakhs only)** to the **NCT of Delhi** towards grants-in-aid for RCH Flexible Pool including Routine Immunization , Pulse Polio and National Iodine Deficiency Disorders Control Programmes during **FY 2016-17.**

1. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid through a cheque in the name of **Finance Secretary, NCT of Delhi.**
2. The State/UT shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
3. The State/UT shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
4. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 19A**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
5. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
6. The expenditure covered by this sanction will be met from the funds provided under Major Head – 3602- Grants-in-aid to Union Territory Governments (Major Head); 02 –Family Welfare (Sub-Major Head); 246- Family Welfare – Reproductive and Child Health (Minor Head); 01- **RCH Flexible Pool including Routine Immunization, Pulse Polio immunization and National Iodine Deficiency Disorder Control Programmes (Sub-Head); 01.07.31- Grants-in-aid - General** in Demand No.42 – Health & Family Welfare during 2016-17 (Plan).
7. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
8. This sanction issues with the concurrence of Finance Division vide Dy. No. **C- 720 dated 15.06.2016.**
