Sub: **Release of balance of first Installment of Grants in Aid for Flexible Pool for Communicable Diseases to Delhi under Revised National TB Control Programme during the year 2016-17**

Sir,

In supersession of earlier sanction no. L-19015/10/2016-TB/87 dated 27.07.2016, I am directed to convey the sanction of the President of India for release of an amount of Rs 1,22,92,000/- (**Rupees one crore twenty two lakhs ninety two thousand only**) to the UT of Delhi out of the total approval of Rs 681.53 lakhs (75% of the total allocated budget (Cash) of Rs 908.70 lakhs for the UT of Delhi for the year 2016-17) as balance of first Installment of Grants-In-Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme for the year 2016-17 as lump sum for undertaking various activities for implementation of RNTCP in the State/UTs. The release of this funds is subject to the UT of Delhi would keep up to its commitments & will be strictly utilized as per the guidelines issued by the MoHFW, GoI and report within a month on compliance of transfer of funds to State Health Society Account. Audited Report and Utilization Certificate till the year 2014-15 have been received from the State Health Society, Delhi and hence no UC is pending.

2. The above amount is in accordance with the instruction issued by the Ministry of Finance (Plan Finance Division) Vide their O.M No. 10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid through Cheque in the name of Finance Secretary, NCT of Delhi.
3. The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The state shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMR/SOEs and Statement of Funds Position, showing unspent balances, fund released as advances, interest earned on unspent balance as and when due.
5. The Budget of UTs will be funded 100% by the Central Government vide O.M Ministry of Finance Department of Expenditure, Finance-II Division dated 05.02.2016.
6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
7. The Expenditure covered by this sanction will be met from the funds provided under Demand no. 42-3602-Grants in Aid to State Government (Major Head), 02-Grants for State Plan Scheme (Sub Major Head) 02789-Special Component Plan for Scheduled Caste (Minor Head), 3514-Flexible Pool for Communicable Diseases GC, 351431-Grants in Aid UTs with legislature for the year 2016-17.
8. The Grants-in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figure of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No. 2(90)-P.II/66 dated 09.10.1966.
