Sub: Release of second Installment of Grants in Aid for Flexible Pool for communicable diseases to Delhi under Revised National TB control Programme during the year 2016-17.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs 94,00,000/-** (Rupees ninety four lakhs only) to the UT of Delhi out of the total approval Rs 2227.17 lakhs (RE 2908.70 lakhs minus Rs 681.53 lakhs have already been released as first installment to UT of Delhi for the year 2016-17) as second installment of GIA for Flexible Pool for Communicable Diseases under Revised National TB Control Programme during the year 2016-17 as lump sum for undertaking various activities for implementation of RNTCP in the State/UTs. The release of this funds is subject to the UT of Delhi would keep up to its commitments & will be strictly utilized as per the guidelines issued by the MoHFW, GoI and report within a month on compliance of transfer of funds to State Health Society Account, Audited Report and Utilization Certificate till the year 2015-16 have been received from the State Health Society, Delhi and hence no UC is pending.


2. The above amount is in accordance with the instruction issued by the Ministry of Finance (Plan finance Division) vide their O.M No. 10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid through Cheque in name of Finance Secretary, NCT of Delhi.
3. The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly summary on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
11. The Budget of UTs will be funded 100% by the Central Government vide O.M Ministry of Finance Department of Expenditure, Finance-II Division dated 05.02.2016.
12. The sanction order is being issued in accordance with Rule 206 to 215 of General Finance Rules, 2005.

The Expenditure covered by this sanction will be met from the funds provided under Demand No. 42- 3602- Grants in Aid to State Government (Major Head), 02- Grants for State Plan Scheme (Sub Major Head) 02789- PuScheduled Caste Sub Plan (Minor Head), 35- Flexible Pool for Communicable Diseases- EAC- 351531- Grants in Aid UTs with legislature for the year 2016-17.
8. The Grants-in-Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No. 2 (90)-P.II/66 dated 09.10.1966.
