Sub.: **Release of balance of Second Installment of Grants in Aid for Flexible Pool for communicable Diseases to six States-Madhya Pradesh, Himachal Pradesh, West Bengal, Tamilnadu, Gujarat and Uttar Pradesh under Revised National TB Control Programme during the year 2016-17.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of Rs.27,39,61,000/- (Rupees twenty seven crore thirty nine lakh sixty one thousand only) to the following six States as balance of Second Installment of Grants-in-Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme during the year 2016-17 as lump sum for undertaking various activities for implementation of RNTCP in the State. The release of this funds is subject to the condition that the State Govt. of these States would keep up to its commitments & will be strictly utilized as per the guidelines issued by the MoHFW, GoI and report within a month on compliance of transfer of funds to State Health Societies' Account. Audited Report and Utilization Certificate till the year 2015-16 have been received from the State Health Societies and hence no UC is pending.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

3. The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. The State shall ensure that 40% /10% (as applicable) of its share based on release of funds by GoI is credited to appropriate accounts.

5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summery on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.

6. The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

The Expenditure covered by this sanction will be met from the funds provided under Demand No.42 - 3601-Grants in Aid to State Government (Major Head), 02-Grants for State Plan Scheme (Sub-Major Head), 02789-Schedule Caste Sub Plan (Minor Head), 35-Public Health-Prevention & Control of Diseases, 3523-Flexible Pool for Communicable Disease-GC, 352331-Grants in Aid General for the year 2016-17.

8. The Grants-in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 09.10.1966.
