I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs. 63,17,40,000.00 (Rupees Sixty Three Crore Seventeen Lakh Forty Thousand Only)** to the State of **Assam** towards liquidation of **Arrears for the F.Y. 2022-23** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the F.Y. **2023-2024**. With this release, the arrears will be partially settled for the F.Y. 2022-23.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be amended time to time.
