I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs. 246,12,28,000.00 (Rupees Two Hundred Forty Six Crore Twelve Lakh and Twenty Eight Thousand Only)** to the State of **Odisha** towards liquidation of **Arrears for the FY 2021-22 and 2022-23** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2023-2024**. With this release, the arrears will be partially settled for the F.Y. 2021-22 and 2022-23.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be amended time to time.

This amount of the sanction order is for reimbursement of the salary expenditure of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012 and D.O.No.27034/21/2021-22/NHM-Finance Dated 12th October, 2021.
