I am directed to convey the sanction of the President for the payment of grants-in-aid of **Rs.144,59,00,000.00 (Rupees One Hundred Forty Four crore and Fifty-nine lakh only)** to the State of **Haryana** towards liquidation of **Arrears for the F.Y. 2022-23 and F.Y. 2023-24** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2025-2026**. With this release, the arrears will be fully settled for the F.Y. 2022-23 and partially settled for the F.Y. 2023-24.

This amount of the sanction order is released for reimbursement of the salary expenditure of regular staff of State Government as per Ministry of Health and & Family Welfare's Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012 and D.O.No.27034/21/2021-22/NHM-Finance Dated 12th October, 2021.
