- The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department the Andaman & Nicobar Island as per approved action plan 2025-26 as entrusted by the Ministry of Health and Family Welfare.
