I am directed to convey the sanction of the President to the payment of grants-in-aid of Rs. **184,01,00,000 (Rupees One hundred Eighty Four crore and One lakh only)** to the State of Assam towards liquidation of Arrears for the F.Y. 2023-24 and 2024-25 for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the F.Y. 2025-26. With this release, the arrears will be fully settled for the F.Y. 2023-24 and partially settled for the F.Y. 2024-25.

This amount of the sanction order is released for reimbursement of the salary expenditure of regular staff of State Government as per Ministry of Health and & Family Welfare's Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012 and D.O.No.27034/21/2021-22/NHM-Finance Dated 12th October, 2021.
