I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs. 521,87,00,000/- (Rupees Five hundred Twenty-one crore and Eighty-seven lakh only)** to the State of **Madhya Pradesh** towards liquidation of **Arrears for the F.Y 2023-24 and 2024-25** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2025-26**. This amount of the sanction order is released for reimbursement of the salary expenditure of regular staff of State Government as per Ministry of Health and & Family Welfare's Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012 and D.O.No.27034/21/2021-22/NHM-Finance Dated 12th October, 2021.
