I am directed to convey the sanction of the President to the payment of grants-in-aid of Rs. **2,93,10,000/- (Rupees Two crore Ninety Three lakh and Ten thousand only)** to the UT of **Jammu and Kashmir** towards liquidation of **Arrears for the F.Y. 2025-26** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2025-26**. With this release, the arrears will be partially settled for the FY 2025-26.
