I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs. 31,56,68,000/- (Rupees Thirty One crore Fifty Six lakh and Sixty Eight thousand only)** to the State of **Mizoram** towards liquidation of **Arrears for the F.Y. 2024-25** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2025-26**.
