
Sir,

NCVBDC (RURAL) by per contra-credit to recovery '2211' – Family Welfare (Major Head), 00 – Family Welfare (Sub-Major Head), 00001 – Direction and Administration (Minor Head), 12 – Flexible Pool for RCH & Health System Strengthening National Health Programme and Urban Health Mission, 1201– Procurement of Supplies and Materials, 120170 – Deduct Recovery under which necessary budget provision exists during the year 2025-26. 
