Subject: Family Welfare Programme - Release of Grants-in-aid during the F.Y. 2024-2025 - for liquidation of Arrears for the F.Y. 2021-22 for implementation of Infrastructure Maintenance [4064], a Centrally Sponsored Plan Scheme.

Sir,

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.11,17,21,000.00 (Rupees Eleven Crore Seventeen Lakh Twenty One Thousand Only)** to the State of **Manipur** towards liquidation of **Arrears for the F.Y. 2021-22** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2024-2025**. With this release, the arrears will be fully settled up to the F.Y. 2021-22.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be amended time to time.

3. As per the D.O letter of Ministry dated 12th October, 2021 the State is required to credit the matching state share commensurate with the Central share in the SNA account of the State Health Society.

4. The expenditure by this sanction will be met from the funds provided under the following head in Demand No.46 – Health & Family Welfare during F.Y.2024-2025. This amount of the sanction order is for reimbursement of the salary expenditure of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012 and D.O.No.27034/21/2021-22/NHM-Finance Dated 12th October, 2021.
