I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.50,19,86,000.00 (Rupees Fifty Crore Nineteen Lakh and Eighty Six Thousand only)** to the UT of **Jammu and Kashmir** towards liquidation of **Arrears for the F.Y. 2023-24** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2024-2025**.
