**Subject: Family Welfare Programme - Release of Grants-in-aid during the F.Y. 2024-2025 - for liquidation of Arrears for the F.Y. 2023-24 for implementation of Infrastructure Maintenance [4064], a Centrally Sponsored Plan Scheme.**

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.9,51,64,000.00 (Rupees Nine Crore Fifty-One Lakh and Sixty-Four Thousand Only)** to the State of Nagaland towards liquidation of **Arrears for the F.Y. 2023-24** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2024-2025**. With this release, the arrears will be partially settled for the F.Y. 2023-24.
