I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.31,99,88,000.00 (Rupees Thirty-One Crore Ninety-Nine Lakh Eighty-Eight Thousand Only)** to the State of **Tripura** towards liquidation of **Arrears for the F.Y. 2023-24** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2024-2025**. With this release, the arrears will be fully settled for the F.Y. 2023-24.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be amended from time to time.
