I am directed to convey the sanction of the President for the payment of grants-in-aid of **Rs.9,73,99,000.00 (Rupees Nine Crore Sventy Three Lakh Ninety Nine Thousand only)** to the State of Jammu and Kashmir towards liquidation of **Arrears for the F.Y. 2024-25** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2024-25**.
