I am directed to convey the sanction of the President for the payment of grants-in-aid of **Rs.291,26,00,000.00 (Rupees Two Hundred Ninety One Crore and Twenty Six Lakh only)** to the State of **Kerala** towards liquidation of **Arrears for the F.Y. 2022-23 and 2023-24** for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during the **F.Y. 2024-2025**. With this release, the arrears will be fully settled for the F.Y. 2022-23 and partially settled for the F.Y. 2023-24.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be amended from time to time.

This amount of the sanction order is released for reimbursement of the salary expenditure of regular staff of State Government as per Ministry of Health and & Family Welfare's Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012 and D.O.No.27034/21/2021-22/NHM-Finance Dated 12th October, 2021.
