Lakshadweep as per approved action plan 2024-25 as entrusted by the Ministry of Health and Family Welfare.

e). Expenditure other than the item No. (d) can be incurred out of the above a location only after the approval of Ministry of Health and Family Welfare.

f). Condition that final accounts have to be settled based on the actual expenditure incurred by UT of Lakshadweep.
