



- d). The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department the Chandigarh as per approved action plan 2024-2025 as entrusted by the Ministry of Health and Family Welfare.
- e). Expenditure other than the item No. (d) can be incurred out of the above a location only after the approval of Ministry of Health and Family Welfare.
- f). Condition that final accounts have to be settled based on the actual expenditure incurred by UT of Chandigarh.
