Subject: Release of Grants-in-Aid under Flexible Pool for Non-Communicable Diseases (NCD) - Sanction reg.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 127200000.00 (Rupees Twelve Crore Seventy Two Lakh Only)** to the State of **GUJARAT** towards Grants-in-aid for **Flexible Pool for Non-Communicable Diseases (NCD)** during the **FY 2021-2022**.

- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
- The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- The State shall ensure that 40%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
- The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. **Provisional Utilization Certificate** for the **FY 2020-21** has been received.
- Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- The sanction order is being issued in accordance with Rules 228 to 245 of General Financial Rules, 2017.
- The expenditure involved is recurring and will be met from the funds provided under Major Head - **3601 - Grants-in-aid to State Governments (Major Head) 06 - Centrally Sponsored Schemes (Sub-Major Head); 06.101 - Central Assistance/Share (Minor Head); 13 - National Rural Health Mission (Sub-head); 13.16 - Flexible Pool for Non-Communicable Diseases - (Support from National Investment Funds - NIF); 13.16.31 - Grants-in-Aid-General**, in Demand No.44- Health & Family Welfare during **2021-2022**.
- The Grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P. II/66 dated 9.10.1966.
