**Subject: Release of Grants-in-Aid under Flexible Pool for Non-Communicable Diseases (NCD) - Sanction reg.**

Sir,

I am directed to convey the sanction of the President of India to the payment of **Rs. 300000.00 (Rupees Three Lakh Only)** to the State of **TRIPURA** towards Grants-in-aid for **Flexible Pool for Non-Communicable Diseases (NCD)** during the **FY 2021-2022**.


2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The State shall ensure that 40%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. **Provisional Utilization Certificate for the FY 2020-21** has been received.
6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The sanction order is being issued in accordance with Rules 228 to 245 of General Financial Rules, 2017.
8. The expenditure involved is recurring and will be met from the funds provided under Major Head - **3601 - Grants-in-aid to State Governments** (Major Head) **06 - Centrally Sponsored Schemes** (Sub-Major Head); **06.789 - Special Component Plan for Scheduled Castes** (Minor Head) **04 - National Rural Health Mission** (Sub-head); **04.16 - Flexible Pool for Non-Communicable Diseases (Support from National Investment Fund - NIF)**; **04.16.35 - Grants for Creation of Capital Assets**, in Demand No.44- Health & Family Welfare during **2021-2022**.
9. The Grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P. II/66 dated 9.10.1966.
