- The State shall ensure that 40% / 10 % (as applicable) of its share based on release of funds by GOI is credited to appropriate accounts.
- The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs / SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- Grant-in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- The **Provisional Utilization Certificates** towards releases made during the year **2020-21** have been received from the State of **CHHATTISGARH**.
- The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
- The expenditure covered by this sanction will be met from the funds provided under Major Head - **3601 - Grants-in-aid to State Governments** (Major Head); **06 - Centrally Sponsored Schemes** (Sub-Major Head); **06.789 - Special Component Plan for Scheduled Castes** (Minor Head) **04 - National Rural Health Mission** (Sub-head); **04.03 - Flexible Pool for Communicable Diseases**; **04.03.31 - Grants-in-Aid-General**, under Demand No.44 – Health & Family Welfare during **2021-2022**.
