The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department **ANDAMAN AND NICOBAR ISLANDS** as per approved action plan 2021-22 as entrusted by the Ministry of Health and Family Welfare.
