3. The placement of funds is subject to the:-



d). The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department **LADAKH** as per approved action plan 2021-22 as entrusted by the Ministry of Health and Family Welfare.


