c). The amount so allocated/earmarked will not be available for re-appropriation by the functional Ministry/Department except with the concurrence of the Agent Ministry/Department.

d). The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department **CHANDIGARH** as per approved action plan 21-22 as entrusted by the Ministry of Health and Family Welfare.

e). Expenditure other than the item No. (d) can be incurred out of the above allocation only after the approval of Ministry of Health and Family Welfare.

f). Condition that final accounts have to be settled based on the actual expenditure incurred by UT **CHANDIGARH**.
