d). The Principal Accounts Officer of the functional Ministry/Department will communicate the computer code Nos. relating to the head (s) concerned to the PAO of the Agent Department **CHANDIGARH** as per approved action plan 2021-22 as entrusted by the Ministry of Health and Family Welfare.

e). Expenditure other than the item No. (d) can be incurred ~~out of the above allocation~~ only after the approval of Ministry of Health and Family Welfare.
