FW Bureaux; 05.01.31 - Grants-in-Aid-General, in Demand No.44-Health & Family Welfare during 2021-2022. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
4. The Sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rule, 2017.
