- The States/UTs shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- The States/UTs shall ensure that 40%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
- The States/UTs shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. Provisional Utilization Certificate for the FY 20120-21 have been received.
- Grants-in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form GFR 12C) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
