Subject: Release of first installment of Grants-in-Aid under Flexible Pool for Non-Communicable Diseases(NCD) (Support from National Investment Funds - NIF) for the Financial Year 2021-2022.

Sir,

I am directed to convey the sanction of the President of India for release of Rs.400000.00 (Rupees Four Lakh Only) to the **UT of Puducherry** towards first installment of Grant-in-Aid under Flexible Pool for Non- Communicable Diseases - (Support from National Investment Funds - NIF) during the financial year 2021- 2022 to the following States/UTs:

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
3. The States/UTs shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The States/UTs shall ensure that 40%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
5. The States/UTs shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. **Provisional Utilization Certificates for the FY 2020-21 have been received.**
6. Grants-in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form GFR 12C) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
8. The expenditure covered by this sanction will be met from the funds provided under Demand No. 44 Major Head - 3602 - Grants-in-Aid to Union Territory Governments with Legislature (Major Head) 06 - Centrally Sponsored Schemes (Sub-Major Head); 06.789 - Special Component Plan for Scheduled Castes (Minor Head); 01-National Rural Health Mission(Sub- head);01.15-Flexible Pool for Non-Communicable Diseases - (Support from National Investment Funds - NIF); 01.15.31-Grants-in-Aid-General- Ministry of Health & Family Welfare during 2021-2022.
