- Grants-in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- The **Provisional Utilization Certificates** towards releases made during the year **2020-21** have been received from the **UT of Jammu & Kashmir**.
- The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
